#### Directions for Use:

Load material tank with Grow Guard and assemble the sprayer per manufacturer instructions. For best adhesion, spray plant when dry. Do not spray if precipitation is expected within 2 hours. Lightly, but thoroughly coat all surfaces of the plant, including the underside of leaves. Reapply once per week after sprouts emerge.

#### Coverage:

Grow Guard may be sprayed via any type of spray applicator, including electrostatic methods. Grow Guard is less viscous (thinner) than water. If using a pump-up sprayer, no adjustment is necessary. If using an electrostatic sprayer, adjust nozzle accordingly to achieve a finer mist, resulting in a better application and less waste.

#### Important:

Plants must be free of any type of oil, wax, powder or other coating that would prohibit material adhesion to foliage. If using Grow Guard in conjunction with such a “coating” product, Grow Guard will be ineffective.
