#### **Directions for Use:**

DO NOT DILUTE. CERARMIST SURFACE GUARD is suspended in a liquid delivery solution which is not meant to be used as a liquid disinfectant; solution is for carrier purposes only and product becomes effective after the dry barrier is bonded in place. Proper surface preparation is required for optimal product performance.

Remove gross filth or heavy soil prior to application. Surface Guard is applied using a hand pump trigger sprayer, low pressure coarse sprayer or electrostatic sprayer. Hold sprayer six to eight inches from the surface to be treated. Spray area until it is thoroughly covered with the product, but not to the point of dripping. Allow surface to air dry or wipe dry with a clean, dry cloth.

Safe for use on painted or unpainted walls, ceilings, woodwork, doors, plaster, sheetrock, concrete, stainless steel, plastic, porcelain, counters and all other interior surfaces not harmed by water. Test in inconspicuous area first.

**Coverage:** 1-gallon coats up to 2500 sq ft of non-porous surface area. Actual coverage may vary based on surface porosity. Undisturbed coating will remain in place for up to 30 days. Reapply sooner if surface has been abraded or exposed to heavy smoke or debris.
